

# **Penn State Federal Credit Union Scholarship Application 2018-2019 Academic Year**

Penn State Federal Credit Union is offering five \$2,000 scholarships to graduating high school seniors.

## **ELIGIBILITY REQUIREMENTS**

1. Applicants must be primary members on a Penn State Federal Credit Union account for at least 12 months and the account must be in good standing. A member with an account in good standing means his or her account has no loan delinquencies or excessive overdrafts.
2. Applicants must be current high school seniors.
3. Applicants must intend to be a full time student at a higher educational institution (college, university, technical school, community college, etc).
4. Penn State Federal Credit Union employees, officials, volunteers and their immediate family members are not eligible to apply.

## **AWARD DISBURSEMENTS**

Five scholarships in the amount of \$2,000 each will be awarded to high school seniors. The awards are for tuition, books and/or fees only and will be paid directly to the school in which the recipient is enrolled. Scholarship winners will be notified by May 1, 2018.

## **APPLICATION INSTRUCTIONS**

To be considered for a Penn State Federal Credit Union Scholarship, high school seniors must submit an application that includes all of the following:

1. Completed and signed application form
2. Official high school transcript and GPA
3. Three letters of recommendation
4. Typed essay of 500 to 1,000 words, doubled spaced on 8.5"x11" white paper with one-inch margins describing academic achievements, extra-curricular activities, community involvement AND/OR career goals.

All applications will be treated as confidential.

Applications are being accepted from November 1, 2017 and must be postmarked by March 1, 2018. Materials postmarked after this date will not be considered.
