

Penn State Federal Credit Union Scholarship Application 2023-2024 Academic Year

Penn State Federal is offering five \$2,000 scholarships to graduating high school seniors or college undergraduate students who will be or are currently attending an accredited college, university or technical school.

ELIGIBILITY REQUIREMENTS

1. Applicants must be primary members on a Penn State Federal account for at least 12 months and the account must be in good standing. A member with an account in good standing means the account has no loan delinquencies or excessive overdrafts.
2. Applicants must be current high school seniors or current college undergraduate students.
3. Applicants must intend to be a full-time student at a higher educational institution (college, university, technical school, community college, etc).
4. Applicants may apply even if a Penn State Federal Scholarship has been awarded in previous years.
5. Penn State Federal employees, officials, volunteers and their immediate family members are not eligible to apply.

AWARD DISBURSEMENTS

Five scholarships in the amount of \$2,000 each will be awarded to the selected recipients. The awards are for tuition or fees only and will be paid directly to the school in which the recipient is enrolled. Scholarship winners will be notified by May 1, 2023.

APPLICATION INSTRUCTIONS

To be considered for a Penn State Federal Scholarship, please submit an application that includes all of the following:

1. Completed and signed application form.
2. Current GPA.
3. Three letters of recommendation. Two references may be from a teacher, professor, counselor, or advisor. Family members or relatives cannot give references.
4. Submit a typed essay of 500 to 1,000 words, doubled spaced on 8.5"x11" white paper with one-inch margins on the following:
Penn State Federal's mission statement is "members helping members in the ordinary and extraordinary moments of their lives". Tell us about an instance where you helped in an ordinary or extraordinary time and what you learned from the experience.

All applications will be treated as confidential.

Applications are being accepted from November 1, 2022 and must be postmarked by March 1, 2023. Materials postmarked after this date will not be considered.
